

UNIVERSITY OF COLOMBO DEPARTMENT OF ECONOMICS STUDY PROGRAMMES IN ECONOMICS – 2020 (English Medium)

1. MPhil/PhD in Economics

The doctoral degree programme is aimed at meeting the academic and professional needs of those who are engaged in research and consultancy, higher levels of teaching and training, administration and management, and advocacy and policy making.

The initial registration is for the MPhil with the provision for upgrading to PhD studies on the basis of performance during the first year of studies.

Admission requirements

- (i) First or Second Class (upper) division in the Special Degree in Economics or related field from a recognized university
 - <u>or</u>
- (ii) Master's Degree in Economics or in a related field from a recognized university. <u>or</u>
- (iii) Any other postgraduate qualifications recognized by the University as equivalent to (ii) above.

A good knowledge of English and adequate computer literacy is essential. Working experience and research experience in the relevant fields are considered as additional qualifications.

2. Masters in Economics (MEcon)

This programme is aimed at to providing an advanced theoretical knowledge and analytical skills in Economics. The course targets those with an intermediate knowledge of Economics who wish to deepen their conceptual and analytical capabilities to meet professional demands and academic capabilities.

Admission Requirements

- (i) First or Second Class Honours Degree in Economics or a related field from a recognized university <u>or</u>
- (ii) First or Second Class in the General Degree with Economics or related field as a major subject from a recognized university or equivalent qualifications and two years of work experience in a related field

or

(iii) Any other Degree with Economics or related field as a major subject, from a recognized university or equivalent qualification recognized by the University of Colombo and five years of work experience in a related field

or

- (iv) Postgraduate Diploma in Financial Economics / Economic Development from the University of Colombo or any other equivalent qualification recognized by the University of Colombo or
- (v) A professional qualification that will be recognized on a case by case basis by the University of Colombo, as equivalent to any of the qualifications from (i) to (iv) above and
- (vi) Good knowledge of English and adequate computer literacy and
- (vii) Gaining the required score at the selection test and at the interview

3. Master of Financial Economics (MFE)

This programme is aimed at providing theoretical and analytical competence in Financial Economics. The course targets those who are already engaged in financial markets and related fields, and who wish to acquire a deeper understanding and practical competence in the subject area to meet professional knowledge and skills.

Admission Requirements:

- (i) First or Second Class Honours in the Special Degree in Economics or a related field, from a recognized university
 - or
- (ii) First or Second Class in the General Degree Examination with Economics or related field as a major subject, from a recognized university or equivalent qualifications and two years work experience in a related field
 - or
- (iii) Any other Degree with Economics or related field as a major subject, from a recognized university or equivalent qualifications recognized by the University of Colombo and five years work experience in a related field
 - or
- (iv) Postgraduate Diploma in Financial Economics/Economic Development from the University of Colombo or any other equivalent qualifications recognized by the University of Colombo . or
- (v) A professional qualification that will be recognized, on a case by case basis by the University of Colombo, as equivalent to any of the qualifications in (i) to (iv) above.
 and
- (vi) Good knowledge of English and adequate computer literacy and
- (vii) Gaining the required score at the selection test and at the interview

4. Postgraduate Diploma Leading to Masters in Tourism Economics and Hotel Management: (PgDTEHM)

This programme is aimed at improving knowledge and skills needed for decision makers, policy designers, planners, researchers, hotel managers and marketeers of the tourism industry. The programme consists of effective applications with interactive learning experience through industry, policy-making bodies, and the university.

The initial registration is for the Postgraduate Diploma with 1 year of studies. On the successful completion of the Postgraduate Diploma, the students are enrolled for the Master's degree in the 2nd year of studies.

Admission Requirements:

- (i) The minimum academic entry qualification is a general degree from a recognized University. Or
- (ii) A Postgraduate Diploma or a Professional Qualification Recognized by the University of Colombo as equivalent to a degree Or
- (iii) Three Year Management Diploma from the Sri Lanka Institute of Tourism and Hotel Management (SLITHM) with Two Years Industry Experience Or
- (iv) Four Year Management Diploma from the Sri Lanka Institute of Tourism and Hotel Management (SLITHM) with One-Year Diploma Programme (non-graduate) in Travel and Tourism Economics and Hotel Management and Two Years Industry Experience Or
- (v) Any other qualifications or experience which demonstrates that a candidate possesses appropriate knowledge and skills at degree level And
- (vi) Good working knowledge of English; applicants should satisfy the University requirement on their language competency.
