



STUDY PROGRAMMES IN ECONOMICS 2023

English Medium

01. MPhil/PhD in Economics

The PhD programme is aimed at meeting the academic and professional needs of those who are engaged in research and consultancy, higher levels of teaching and training, administration and management, and advocacy and policy making.

The initial registration is for the MPhil with the provision for upgrading to PhD studies on the basis of performance during the first year of studies.

Admission requirements:

- (i) First or Second Class (upper) division in the Special Degree in Economics or related field from a recognized university
or
- (ii) Master's Degree in Economics or in a related field from a recognized university.
or
- (iii) Any other postgraduate qualifications recognized by the University as equivalent to (ii) above.
A good knowledge of English and adequate computer literacy is essential. Working experience and research experience in the relevant fields are considered as additional qualifications.

Duration: 3 years, by research under supervision

02. Masters in Economics (MEcon)

MEcon programme is aimed at providing an advanced theoretical knowledge and analytical skills in Economics. The course targets those with an intermediate knowledge of Economics who wish to deepen their conceptual and analytical capabilities to meet professional demands and academic capabilities.

Admission Requirements:

- (i) First or Second Class Honours Degree in Economics or a related field from a recognized university
or
- (ii) First or Second Class in the General Degree with Economics or related field as a major subject from a recognized university or equivalent qualifications and two years of work experience in a related field
or
- (iii) Any other Degree with Economics or related field as a major subject, from a recognized university or equivalent qualification recognized by the University of Colombo and five years of work experience in a related field
or
- (iv) Postgraduate Diploma in Financial Economics/Economic Development from the University of Colombo or any other equivalent qualification recognized by the University of Colombo
or
- (v) A professional qualification that will be recognized on a case by case basis by the University of Colombo, as equivalent to any of the qualifications from (i) to (iv) above
and
- (vi) Good knowledge of English and adequate computer literacy
and
- (vii) Gaining the required score at the selection test and at the interview

03. Master of Financial Economics (MFE)

MFE programme is aimed at providing theoretical and analytical competence in the field of Financial Economics. The course targets those who are already engaged in financial markets and related fields, and who wish to acquire a deeper understanding and practical competence in the subject area to meet professional knowledge and skills.

Admission Requirements:

- (i) A Bachelor's Degree from a recognized University including 30 credits in the relevant subject area;
Or
- (ii) With prior learning/work experience equivalent to 30 credits in the relevant subject area.
or
- (iii) A qualification in the relevant subject area equivalent to (i) or (ii) above
or
- (iv) A. Completion of NVQ level 7, as determined by the Higher Degrees Committee, Faculty Board and Senate
and
- (v) Good knowledge of English and adequate computer literacy
and
- (vi) Gaining the required score at the selection test and at the interview

Duration: 1 Year by course work; Students may choose either Saturday or Sunday classes

04. Postgraduate Diploma Leading to Masters in Tourism Economics and Hotel Management (Pg. DTEHM)

This programme is aimed at improving knowledge and skills needed for decision makers, policy designers, planners, researchers, hotel managers and marketers of the tourism industry. The programme consists of effective applications with interactive learning experience through industry, policy-making bodies, and the university.

The initial registration is for the Postgraduate Diploma with 1 year of studies. On the successful completion of the Postgraduate Diploma, the students are enrolled for the Master's degree in the 2nd year of studies.

Admission Requirements:

- (i) The minimum academic entry qualification is a general degree from a recognized University.
or
- (ii) A Postgraduate Diploma or a Professional Qualification Recognized by the University of Colombo as equivalent to a degree
or
- (iii) Three Year Management Diploma from the Sri Lanka Institute of Tourism and Hotel Management (SLITHM) with Two Years Industry Experience
or
- (iv) Four Year Management Diploma from the Sri Lanka Institute of Tourism and Hotel Management (SLITHM) with One-Year Diploma Programme (non-graduate) in Travel and Tourism Economics and Hotel Management and Two Years Industry Experience
or
- (v) Any other qualifications or experience which demonstrates that a candidate possesses appropriate knowledge and skills at degree level
and
- (vi) Good working knowledge of English; applicants should satisfy the University requirement on their language competency.

Duration: 2 years, as the 1st year for the Postgraduate Diploma with the provision for the 2nd year for the Master's degree

Admission Requirements:

- (i) Degree in Economics or related discipline from a recognized University/Institution
or
- (ii) Any other Degree with one year's work experience relevant to the subject matters of the postgraduate diploma
or
- (iii) Professional qualification from a recognized professional body equivalent to a Bachelors' degree acceptable to the Faculty Board of the Faculty of Arts with one year's post qualifying work experience relevant to the subject matters of the postgraduate diploma.
or
- (iv) Higher Diploma or any other qualification(s) equivalent to a Bachelors' degree from a recognized University/institution with one year's work experience relevant to the subject matters of the postgraduate diploma or a higher diploma with three years' post qualifying experience relevant to the subject matters of the postgraduate diploma acceptable to the Board of the Faculty of Arts.
and
- (v) Gaining the required score at the selection test and at the interview.

or
- (iii) A professional qualification that will be recognized on case by case basis by the University of Colombo
and
- (iv) Gaining the required score at the selection test and at the interview
