Postgraduate Diploma in Economic Development (Pg. DED)

The programme aims to provide specialized skills and training in a number of branches in economics to meet the challenges of current local and global economic trends. The course targets those who are interested in the fields related to Microeconomics, Macroeconomics, Finance and Banking, Development Studies, Project Management, Transport and Logistics, and Quantitative Techniques with data analysis.

Admission Requirements:

- (i) Degree in Economics or related discipline from a recognized University/Institution or
- (ii) Any other Degree with one year's work experience relevant to the subject matters of the postgraduate diploma

or

(iii) Professional qualification from a recognized professional body equivalent to a Bachelors' degree acceptable to the Faculty Board of the Faculty of Arts with one year's post qualifying work experience relevant to the subject matters of the postgraduate diploma.

or

(iv) Higher Diploma or any other qualification(s) equivalent to a Bachelors' degree from a recognized University/institution with one year's work experience relevant to the subject matters of the postgraduate diploma or a higher diploma with three years' post qualifying experience relevant to the subject matters of the postgraduate diploma acceptable to the Board of the Faculty of Arts.

and

(v) Good working knowledge in English and computer literacy. Gaining the required score at the selection test and at the interview.

Duration: 1 year by coursework and minor dissertation

Course fee: For Local Candidates: Rs. 150,000.00, payable in 2 equal instalments

For Foreign Candidates: USD 1500 paid in one instalment.
