

PSC 4187 - Gender in Political and Policy Processes

Introduction

This course will take off from PSC 3261 and focus on specific aspects of gender and politics. The scope of the course covers gender and political participation, gender and public policy, gender and social development, gender and leadership, gender and poverty, and gender and education.

Objectives

This course is designed to:

- i. Introduce students to feminist theoretical perspectives on the processes of political, economic and cultural change.
- ii. Make students familiar with research- based knowledge on gender- related issues in Sri Lanka, and
- iii. Enable students to critically assess political, economic and policy from the perspectives of gender studies.

3. Gender, Social Change and Culture

- i. Gender, class, caste and ethnicity.
- ii. Women and the mass media
- iii. Women in cinema, literature and theater.

4. Gender, Economic Development & Public Policy in Sri Lanka

- i. Poverty alleviation programmes their impact on women
- ii. Rural development and issues of rural women.
- iii. Women, education and employment
- iv. Women and industrial labour.

5. Gender and Politics of Resistance, & Issues of Emancipation of Women in Sri Lanka.
- i. Radical politics, women and gender issues
 - ii. Women and Sinhala nationalist politics.
 - iii. Women and Tamil nationalist politics.

6. Gender, Civil Society and Social Movements
- i. Gender and civil society space
 - ii. Women's movements in Sri Lanka
