The Editorial Committee for the Annual Research Symposium of the University of Colombo invites the academic staff members and postgraduate students of the University of Colombo to submit abstracts/extended abstracts to be considered for presentation at the Technical Sessions of the Annual Research Symposium in November 2019. The abstracts should be based on original research work and, if accepted, should be presented by a staff member or a postgraduate student of the University of Colombo. All accepted abstracts will be published in the Proceedings Book of the Annual Research Symposium 2019, University of Colombo.

# Deadline for submission of abstracts: 19 July 2019

To be considered for evaluation, each submission should include the following documents.

- 1. Abstract <u>not exceeding 300 words</u> (The file name should be: Abstract + conference registration number)
- 2. Extended abstract (inclusive of background, objectives, research design/materials and methods, results/ findings, conclusions) <u>not exceeding 1000 words</u> (The file name should be: Extended abstract + conference registration number)
- 3. The author's declaration form.

Guidelines for preparation of the abstract and extended abstract are attached. Please follow the instructions carefully. Abstracts/extended abstracts that are not prepared according to the guidelines provided, or are submitted after the deadline, will not be considered for review. The Editorial Committee reserves the right to make alterations to the text of the abstract which will improve its quality.

Please note that your abstract will only be accepted for review if you have successfully registered for the conference.

Authors should upload their abstracts/extended abstracts to the EasyChair abstract submission system (<a href="https://easychair.org/my/conference?conf=iconarts2019">https://easychair.org/my/conference?conf=iconarts2019</a>) by 19 July 2019. Please read the guidelines carefully since they have been changed to suit online submission and review of abstracts.

## Guidelines for submission of abstracts/extended abstracts

#### 1] Guidelines for preparation of abstracts

- i. The abstract must report original research.
- ii. An author may submit <u>one abstract as single-author and one abstract as co-author</u> **OR** <u>no more</u> than three abstracts as co-author.
- iii. The title should be brief and explain the study reported. Capital letters should be used only for the first letter in the first word of the title and proper nouns.
- iv. In the first submission to EasyChair the abstracts **should not** include the author/s names and institutional affiliations.
- v. The text of the abstract should not exceed 300 words.
- vi. Standard abbreviations of SI units should be used.
- vii. The abstract should be coherent and free of language errors.
- viii. A maximum of five keywords should be provided.
- ix. Acknowledgements should be restricted to the names of funding agencies providing sponsorship.
- x. Use font "Times New Roman" size 11 with 1.5 spacing on A4 paper.

## 2] Guidelines for preparation of extended abstract (should be submitted with each abstract)

- i) The text should not exceed 1000 words (excluding references).
- ii) In the submission to EasyChair the extended abstract **should not** include the author/s names and institutional affiliations.
- iii) The extended abstract should cover the following aspects: Background, Objectives, Research Design/Materials and Methods, Results/ Findings, Conclusions and References.
- iv) The extended abstract should be coherent and free of language errors.
- v) Tables and diagrams can be included and should be referred to in text as Table 1 or Fig. 1.
- v) References should be limited to only essential ones.
- vi) Use font "Times New Roman" size 11 with 1.5 spacing on A4 paper.

## 3] Declaration by the authors

- (i) The annexed declaration form must be signed and returned by the Corresponding Author via email (scanned copy) along with each abstract/extended abstract submitted.
- (ii) All correspondence will be addressed to the Corresponding Author. If the Corresponding Author is a student, it is mandatory that the declaration form should be signed by the supervising author/s.
- (iii) The abstracts should be presented by a staff member or a postgraduate student of the University of Colombo. In the event that the presenter indicated in the application is unable to present the paper, it is the responsibility of the Corresponding Author either to withdraw the paper in advance or arrange for one of the Co-Authors to present the paper.

## 4] Author(s)' names and institutional affiliation

On acceptance, the author(s) should submit a copy of the short abstract with author(s) names and affiliation in the following format:

- Capital letters should be used only for the initials and the first letters of the surnames of authors.
- The address of the Institution in which the work was carried out should be included under the author's name.
- If the collaborators are from different Institutions, the addresses of the Institutions should be included in brief. In this case, the addresses of the co-authors should be indicated by a number in superscript after the authors' names and before the respective addresses (as shown below).
